The Sexual Violence Research Initiative is undertaking a process to recruit 10 young researchers between the ages of 18-24 to attend the upcoming SVRI Forum 2017 as well as 5 facilitators to support them to participate at the conference. The Forum is scheduled to take place from the 18-21 September in Rio De Janeiro, Brazil.

Applications should be submitted by NGOs based in Sub-Saharan Africa, Eastern Europe and Latin America and the Caribbean that work with young people and children and have experience undertaking participatory research with young people affected by violence.

Deadline: 13 March 2017 at 23:59 (South African Time).

Psychol. ePub, 2017: This study examines whether constructs derived from the interpersonal-psychological theory of suicide (perceived burdensomeness, thwarted belongingness, and fearlessness about death; Joiner, 2005) were associated with suicidal ideation among female Veterans who had experienced military sexual trauma, when adjusting for known risk factors for suicide. Request for proposals: Making the connection between child marriage and SGBV, HIV/AIDS and education: The Regional SRHR Fund is soliciting a call for proposals for organizations working in Southern Africa (Malawi, Mozambique, South Africa, Zambia and Zimbabwe) on education, Sexual and Gender-Based Violence and Education. Proposals for grants will be considered from organisations that have put forward innovative and strategic ways to address the inter-sectionality between child marriage and one or more of the following three topics: Sexual and Gender-Based Violence, HIV/AIDS and education at the national level that have the potential for scale up to the regional level. The maximum funding available per proposal is \$US 15,000. Deadline: 27 March 2017. [Source: Sex Rights Africa Network].

Funding opportunity: 2017-2018 Mariam K. Chamberlain Award: The Mariam K. Chamberlain Dissertation Award will support a doctoral student who is a first-generation college graduate, including immigrant students, as he or she works on a dissertation under the close supervision of a senior dissertation advisor over one academic year. Preference will be given to a student who identifies as a woman. 'They are heroes': Angelina Jolie honours survivors of sexual violence in Cambodia, The Guardian, 22 February 2017: Angelina Jolie has paid tribute to the survivors of forced marriage under the Khmer Rouge and pledged to continue advocating on behalf of women and girls who suffer from sexualized violence in conflict.

<u>Teaching boys about healthy relationships: 'They need it from birth', The Guardian, 20 February 2017</u>: "Misogyny is getting worse and it's toxic for boys to grow up in a society where girls and women are treated poorly," says Birmingham head teacher Sarah Hewitt-Clarkson.

Malawi: Constitution will no longer allow child marriage, Girls Not Brides, 15 February 2017: 14 February was a historic day for girls in Malawi. Parliament voted to amend the Constitution to make marriage before the age of 18 illegal, removing a provision that allowed children to marry at 15 with parental consent.
