**[I. SVRI member request: CSO survey for the global study on implementation of UNSCR 1325](#)**

Calling on CSOs working on Women Peace and Security to share your insights on 15 years of UNSCR 1325 implementation! The Global Network of Women Peacebuilders (GNWP), in partnership with the International Civil Society Action Network (ICAN) the NGO Working Group on Women, Peace and Security (NGO WG on WPS) and Cordaid is conducting a survey among CSOs from around the world to solicit their views on the implementation of UNSCR 1325 in the past, and recommendations for the future. The views you share will directly feed into the Global Study on the Implementation of UNSCR 1325, called for under UNSCR 2122 to "highlight examples of good practice, implementation gaps and challenges, and priorities for action. **[A brief report on rape myth acceptance: Differences between police officers, law students, and psychology students in the United Kingdom. Sleath E, Bull R. Violence Vict, 30: 136-147, 2015](#)**: This article determines whether police officers do accept stereotypical rape myths at a higher level compared to members of other populations. **[Meta-analysis of the prevalence of unacknowledged rape. Wilson L.C, Miller K.E. Trauma Violence Abuse, ePub, 2015](#)**: Many sexual violence survivors do not label their experiences as rape but instead use more benign labels, such as "bad sex" or "miscommunication." This study conducts a meta-analysis to estimate the mean prevalence of unacknowledged rape and to inform our understanding of methodological factors that influence the detection of this phenomenon. **[Risk and protective factors for sexual and dating violence victimization: A longitudinal, prospective study of Latino and African American adolescents. East PL, Hokoda A. J. Youth Adolesc, ePub, 2015](#)**: This article seeks to identify the risk and protective factors evident in early adolescence that are associated with sexual and dating violence victimization in late adolescence. **[Friends matter: Protective and harmful aspects of male friendships associated with past-year sexual aggression in a community sample of young men. Jacques-Tiura A.J, Abbey A, Wegner R, Pierce J, Pegram S.E, Woerner J. Am. J. Public Health, ePub: e1-e7, 2015](#)**: This article extends past research on sexual violence etiology by examining the impact of perceived pressure to have sex by any means and the types of objectifying and egalitarian language that friends used when discussing women. **[Hidden voices: prevalence and risk factors for violence against women with disabilities in Nepal. Puri M, Misra G, Hawkes S. BMC Public Health, 15: 1610, 2015](#)**: Critical gaps exist in empirical data on the extent, risk factors, access to care, socio-economic and health consequences of violence among women with disabilities in Nepal. This paper addresses some these gaps and aims to promote evidence-informed policy and programme responses in Nepal. [Source: SafetyLit].

Violence Vict, 30: 49-65, 2015](#)**: This study investigates the relations between attachment dimensions, exposure to accumulated childhood traumas, reaction to childhood sexual abuse disclosure, and adult sexual revictimization. Violence Vict, 30: 163-176, 2015](#)**: This article examines the influence of interpersonal functioning as a mediator in the relationship between child sexual abuse and depression symptoms, after accounting for the influence of child physical abuse. PLoS ONE 10\(2\): e0118234, 2015](#): This systematic review synthesises existing evidence from the strongest study designs to estimate the impact of IPV on women's use of contraception.
